Dangerous Goods & Hazardous Chemicals Foundation Courses (VICTORIA)

Dangerous Goods (Storage and Handling) Regulations 2012 and Code of Practice for the Storage and Handling of Dangerous Goods 2013.

Model Work Health and Safety laws (WHS Act and Regulations) produced by Safe Work Australia have been adopted in New South Wales, Queensland, the Australian Capital Territory, the Commonwealth and the Northern Territory, South Australia and Tasmania. However, adoption of these laws has been delayed in jurisdictions of Victoria and Western Australia. Transitional arrangements will vary depending on the specific regulations and for the individual jurisdictions.

These seminars/workshops will provide an introduction and update on Dangerous Goods and Hazardous Chemicals legislation including the Storage, Handling and Transport of Dangerous Goods, Segregation, Placarding, Manifests, and Hazardous Chemicals / Hazardous Substances.

DANGEROUS GOODS & HAZARDOUS CHEMICALS FOUNDATION COURSE (VICTORIA)

Duration: 3.5 hours

Pre-requisites: There are no pre-requisites for attending the *Dangerous Goods & Hazardous Chemicals foundations course.*

Audience: The *Dangerous Goods & Hazardous Chemicals foundations course* is intended for personnel requiring a basic or general understanding of Dangerous Goods Storage, Handling and Transport requirements.

Outcomes: Participants should achieve the basic knowledge necessary for them to participate in Dangerous Goods hazard identification, risk assessment and control.



The Workshop will cover:

- An overview of OHS/WHS/DG legislation in the *Dangerous Goods (Storage and Handling) Regulations 2012 (Victoria)*
- Examining the term 'Persons Conducting a Business or Undertaking' (PCBU)
- Changes to Australian Dangerous Goods Code ADG7 edition
- Comparison of the Dangerous Goods labelling with Globally Harmonised System (GHS) labelling
- Chain of responsibility and safety obligations for PCBUs (which includes manufacturers, occupiers, loaders, transferors, contractors, etc.)
- Understanding the terminology (Proper Shipping Name, Class, Subsidiary Risk, Packing Group, UN Number, HAZCHEM Code, and more)
- Detailed review of the 9 Classes of Dangerous Goods from ADG7
- Incompatibilities and their hazards
- Details of the changes to Safety Data Sheets (SDS), their content and application
- Sources of information

DANGEROUS GOODS (STORAGE, HANDLING & TRANSPORT)

FOUNDATION COURSE

Duration: 3.5 hours

Pre-requisites: Participants attending the *Dangerous Goods (Storage, Handling & Transport) foundations course* should have attended the *Dangerous Goods (Foundations) seminar*, or have a sound understanding of the detail covered in that workshop, including the 9 Classes of Dangerous Goods from ADG7.

Audience: The *Dangerous Goods (Storage, Handling & Transport) foundations course* is intended for personnel involved in Dangerous Goods hazard identification, risk assessment and control.

Outcomes: Participants should achieve a comprehensive understanding of the application of the new regulations to the storage and handling of Dangerous Goods. This includes an awareness of Dangerous Goods Substance Registers, Manifests, Segregation and Placarding.

The Seminar / Workshop includes several practical exercises and will cover:

- Dangerous Goods and Substance Registers, Manifests and threshold Quantities
- Segregation and compatibility of chemicals
- The segregation rules and techniques segregation devices (stores and vehicles)
- Placarding of stores, vehicles and containers
- Bunding rules for containing a potential chemical spill
- Transport documentation
- · Compliance strategies, and the use and purpose of Australian Standards
- Sources of information
